- 1. The Ministry of Agriculture invites sealed bids from eligible and qualified bidders for the Supply of the following equipment:
 - I. Lot 1: Procurement of One (1) New 4x4 Double Cab Pick Up
 - II. Lot 2: Procurement of One (1) New All-Terrain Vehicle
- 2. Bidding will be conducted through the National Competitive Bidding (NCB) procedures of the National Procurement and Tender Administration Board, specified in the Procurement Act 2003 and the Procurement Policies and Guidelines of the International Fund for Agriculture Development (IFAD).
- 3. Qualification requirements include:
 - a) Experience as a supplier in carrying out of supply and services of this nature for the last 3 (three) years;
 - b) Valid NIS and GRA Compliance Certificates for local firms
 - c) Manufacturer Authorization or Dealership agreement (three years and older)

Additional Qualification Requirements are stated in the Instructions to Bidders (ITB), the Bid Data Sheet (BDS) and Section 3 Evaluation and Qualification Criteria of the Tender Documents.

- 4. A complete set of Bidding Documents (in pdf on a CD) may be purchased by interested bidders on the submission of a written application to the address below (6) and upon payment of a non-refundable fee of One Thousand Guyana dollars (G\$1000).
- 5. The Commencement date for the inspection/acquisition of Bidding Documents is **August 13, 2019.** The Bidding Documents may be inspected/acquired during normal working hours.
